## Facility

This is a working farm. Dogs must be on leash at all times! Please pick up after your dogs. RVs are welcome but must be self contained. There are no hookups. There is an IGA supermarket and restaurants 2 miles from the site.

## Awards

Conformation: Ribbons awarded for 1st through 4th place, with rosettes for premium awards. Dog related prizes for premium awards.

ATTENTION EXHIBITORS These shows will be judged and run by the Show Rules of the Australian Shepherd Club of America. Dogs must be ready for judging. Neither the club nor the chairman will be responsible or obligated to furnish any services for notifying exhibitors or their agents of class judging. Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the show committee. Entry fees will only be refunded if the refund request is received before the pre-entry closing date, no entry fee will be

refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fire, Acts of God, or public emergency. The show-giving club, the Show Chairman, their agents, officers, and/or committee shall assume no responsibility for injury to children. Judges may be substituted. All dogs must be leashed or crated at all times, except when competing. No electrical and/or mechanical training devices will be permitted on the show grounds. Please clean up after your dogs. No bitches in season in or near the obedience ring. Class Conflicts: Please notify the appropriate ring official of your conflict. For the safety of your dogs and others all dogs must have current vaccinations against rabies, distemper/parvo, you are asked to bring a copy of the rabies certificate with you.

**Directions** (call for directions if not coming from the following areas):

From Atlanta – Take I-85 north from Atlanta. Take GA-400 North. Turn left at the first stoplight on GA-369 West. Go approximately 11 miles. Turn right (north) on Yellow Creek Rd. Go about 10 miles. Turn left on GA-53 West. Go about 2 miles. Turn left on Four Mile Church Rd. Go 7/10 of a mile. Driveway is on the right, mailbox on the left #912.

From Chattanooga – Take I-75 South. Exit at GA-53 East. Travel approximately 45 min – 1 hour east on GA-53. When you arrive at GA-515, go straight ahead, and the road will become GA-Bus-53 South. Go 6.4 miles until you arrive at a 4-way stop. Turn left onto GA-53 East. Go another 6.4 miles. Look for mile marker 26 and then turn right on Four Mile Church Rd (a few hundred feet after mile maker 26). Go 7/10 of a mile. Driveway is on the right, mailbox on the left #912.

From Marietta - Take I-75 North, continue on I-575 North. Continue north when 575 becomes Hwy 515. Go right on Hwy 108/53. Continue about 7 miles. After milemarker 26, turn right on Four Mile Church Rd. Go about 7/10 of a mile. Mailbox is on the left #912 and gravel driveway is on the right.
